I AGENDA

B. WINTER SHUTDOWN SCHEDULE The Center will be closed on December 19th 2011 and re-open on January 3rd 2012. Work to be done on upgrading the PCs with Windows-7, as already indicated.

APPLICATION TO USE LAB BY NON-SENIOR GROUP Kim reported that she had received a request from Parks & Rec to use the Lab because one of their classes, on "Creating Computer Games", originally intended to be taught at Branciforte Middle School, had been refused the space there due to development of their own programs. The Special Classes coordinator asked if it would be possible to move the class to SCCOSC. Discussion took place, and it is the consensus of the Senior Council that this proposal be rejected, since the group do not meet the requirements of age 55 or more and are therefore non-members of the Senior Computer Center and, although supervised by a teacher, there was no comprehensive plan on who was going to manage the network, purchase and install the software required, etc.

There being no further business to come before the meeting, and upon motion duly made and seconded, it was unanimously RESOLVED, to adjourn.
